#### INTRODUCTION TO SAVE THE CHILDREN

Save the Children is the world's leading independent organisation for children.

Save the Children Italia (SC Italia) was created as an ONLUS in 1998 and is now a prominent member of Save the Children International.

## **JOB PURPOSE**



The primary purpose of the post holder is to develop and drive coherent advocacy initiatives for Save the Children Italy that are in line with organisational priorities, in order to ensure the achievement of domestic and EU advocacy and programme strategic objectives. The post holder will be responsible for assisting in the delivery of advocacy components of the programme Italy EU and in coordinating the development of documents, in order to promote Save the Children in Italy, its advocacy and policy positions, messages and programme work. The position requires close collaboration with programme and communication functions, in order to drive consistent advocacy initiatives with their support. Moreover the position requires close collaboration with other key stakeholders (networks, NGOs, institutional authorities).

The post holder will be expected to:

- Contribute to the definition and implementation of the Italy-Europe programmes strategy.
- Guarantee the effectiveness of advocacy activities for the development of Italy-Europe Programmes.
- Coordinate policy advisors and other staff in implementing agreed policy strategies in line with thematic priorities of Italy-Europe Programmes.
- Coordinate the development of policy analyses, position papers and other documents for ensuring policy change at the national and European level.
- Interact and plan in coordination with International Programme Advocacy.
- Coordinate Advocacy and Policy activities and manage budget and staff of the area.
- Manage institutional relationships.

#### **RESPONSABILITIES:**

#### Fulfilling advocacy objectives

The post holder is accountable for ensuring achievement and realization of Save the Children Italy EU advocacy and policy objectives in close cooperation and reporting to Italy-Europe Programmes Head of Division.

- Advocate and manage institutional relations at European, National, regional, local level
- Develop and drive forward strategy for achieving programme advocacy and policy objectives and contributing towards thematic priorities.
- Undertake agreed advocacy as a key facilitator supporting teams in line with Save the Children overall advocacy strategy and aims.
- Develop, support and enable internal coordination system and information sharing mechanisms to ensure advocacy efforts and initiatives by different staff are linked, coherent, complementary and mutually reinforcing.
- Develop and maintain Save the Children Italy-Europe Programmes advocacy calendar identifying main advocacy opportunities and events.
- Develop and update a knowledge base of institutional contacts and other relevant advocacy stakeholders
- Support to the creation and activity of scientific committees and experts on the
  positioning of specific issues, and support to facilitate the involvement and wider
  mobilization on child and youth rights. Support to the implementation of consultation
  initiatives with stakeholders, children, and youths to define policies.
- Initiation and organization of advocacy events (seminars, report presentation, studies) at European, national, and local level.



## Representation

- Cultivate a network of contacts— Public Authorities, NGOs, networks, universities, local authorities, international organization staff—to spread core and tailored advocacy messages as needed. Promote and manage relations at European, national, and local level.
- Coordination of institutional interactions (parliamentary hearings, institutional roundtables, and similar events)
- Support to the activity of networks sponsored by Save the Children in collaboration with other rights organizations, particularly with Crescere al Sud.

# Development of documents

• The post holder is responsible to draft concise, persuasive top-line advocacy messages and wider documents as needed and in coordination with Programme Managers and programme staff; this includes briefing documents, talking points, speeches, press releases, presentations, proposals.

## Reporting

- The post holder is responsible for producing and ensuring high quality reports and other documents on advocacy and programmes related issues, and their circulation.
- He/she is responsible for the elaboration of documents presenting advocacy objectives, activities, and policies regarding the organization.

## **Monitoring Impact**

Develop indicators, means of verification and monitoring tools in order to continually
assess advocacy-policy approaches' strengths and weaknesses, analyse impact on children
and document lessons learned.

#### Team work

- Actively promote effective formal and informal communication among all staff members
  and other programme and support staff with the aim of achieving the programme
  objectives. The job holder is responsible for closely coordinating and collaborating with
  Save the Children Italy team and different project groups.
- Maintain links with Communication for the development of advocacy contributions in campaigning initiatives. Coordinate relationship within International Advocacy and with European advocacy working groups.

## Other

- The post holder must closely coordinate and collaborate with Italy-Europe Programmmes Head of Division in driving forward agreed responsibilities.
- The post holder is required to comply with Save the Children policy and practices requirements with respect to health and safety, child protection, equal opportunities, and other relevant policies and procedures. The post holder will at all times implement



her/his responsibilities with due regard to SC commitment to safeguarding children in accordance with the Child Safeguarding Policy and Procedures.

- The post holder will be responsible to manage the advocacy policy department budget and staff.
- The post holder will be responsible to fulfill any other duty assigned by the Italy-Europe Programmmes Head of Division.

### EDUCATION, COMPUTER AND LANGUAGE SKILLS

- In-depth knowledge of welfare and education policies for children and youths in Italy, specifically in relation to vulnerable minors.
- Proven analytic skills on publications of economic policy for the public sector (central, regional, and local administrations) and knowledge of rules of European funding opportunities related to children and youths projects.
- Excellent public relations skills in order to communicate with a range of different, stakeholders, organisations/individuals, partner NGOs, institutional donors, companies, etc.
- Minimum ten years experience designing and implementing policy and advocacy strategies, including event coordination and policy drafting.
- Consolidated experience to perform under pressure and emergency situations.
- Very good internal communication skills in order to interact effectively with a wide range
  of staff across the organisation, notably the Programme Coordinators and Project
  Managers.
