# JOB PURPOSE

The proposal writer will serve as primary writer for the development of project's proposals to be presented for funding to main institutional donors of Save the Children Italia (EuropeAid, Italian Cooperation, Local Institutions, etc.).

S/he will report to the Institutional Partnership Manager, and will work closely with the Regional Programmes team, the Programme Quality & Support team, the Grant Management team.

## **RESPONSABILITIES:**

- Collect and keep updated information on guidelines, procedures, formats and other related information needed for the presentation of projects' proposals to main SCIT donors (EuropeAid, Italian Cooperation, Local Institutions, etc.)
- In cooperation with the respective SC Country Offices collect and keep updated country information (situation analysis, needs assessments, country strategies, etc...) needed for the development of quality projects proposals.
- Identification and formulation of projects proposals responding to specific donors financing opportunities or call for proposals.
- Writing and development of Concept Notes and Full Proposals for participation in EuropeAid call for proposals.
- Short missions in the field (2-4 weeks), where required, to collaborate with the SC Country Offices on proposals writing.
- Consult and cooperate with thematic advisors for the development of specific projects proposals.
- Formulation of projects budget in collaboration with the Grant officer.
- Final editing and set up of projects proposals including related requested documentation as per donors guidelines.
- Ensure compliance of proposals with Donor's guidelines and procedures.
- Ensure all proposals are reviewed and approved by responsible management before final submission to the donor.
- Participate in capacity development process of SC Country Offices.
- Comply with all relevant Save the Children policies and procedures with respect to child rights and safeguarding, health and safety, equal opportunities and other relevant policies.
