# JOB PURPOSE

The proposal writer will serve as primary writer for the development of project's proposals to be presented for funding to Save the Children main institutional donors (EuropeAid, Italian Cooperation, Italian Local Institutions).

S/he will work closely with Institutional Partnership Coordinator, Programme Thematic Development & Quality Head, Programme Officers and Grant Managers.

The position is being opened in order to consider during the time of the project (2013) the real necessities of the structure of the International Programmes Department. SC Italy's 2011-2015 strategy includes in fact the objective of increasing the income coming from institutional donors and the project should prove the feasibility and sustainability of the activity.

## **RESPONSABILITIES:**

- Collect and keep updated information on guidelines, procedures, formats and other related information needed for the presentation of projects' proposals to main SC donors (EuropeAid, Italian Cooperation, Local Institutions, etc.)
- In cooperation with the respective SC Country Offices collect and keep updated country information (situation analysis, needs assessments, country strategies, etc...) needed for the development of quality projects proposals.
- Identification and formulation of projects proposals responding to specific donors financing opportunities or call for proposals.
- Writing and development of Concept Notes and Full Proposals for participation in EuropeAid call for proposals.
- Consult and cooperate with thematic advisors for the development of specific projects proposals.
- Formulation of projects budget in collaboration with the Grant officer.
- Final editing and set up of projects proposals including related requested documentation as per donors guidelines.
- Ensure all proposals are reviewed and approved by responsible management before final submission to the donor.
- Comply with all relevant Save the Children policies and procedures with respect to child rights and safeguarding, health and safety, equal opportunities and other relevant policies.
