Introduction to Save the Children

Save the Children is the world's leading independent organisation for children.

OUR VISION is a world in which every child attains the right to survival, protection, development and participation.

OUR MISSION is to inspire breakthroughs in the way the world treats children, and to achieve immediate and lasting change in their lives

Save the Children Italia (SC Italia) was created as an ONLUS in 1998 and is now a prominent member of Save the Children International.

KEY AREAS OF ACCOUNTABILITY:

Monitoring and Evaluation (M&E):

- Oversee planning of needs assessments in SCIT high priority programmes within our portfolio in coordination with other external sector agencies, ensuring assessment findings are documented and include an analysis of children's needs. Lead development of Save the Children's regional programme baseline surveys where required.
- Lead development of M&E plans for SCIT portfolio programmes and their roll out.
- Support sector technical staff to carry out monitoring and evaluation of project activities as agreed in M&E frameworks and plans.
- Contribute to child-focused and child-led programme implementation, by promoting child-friendly qualitative methodologies in MEAL processes
- Ensure that data collection and entry methodologies used in SC IT programmes are standardised, enabling the specific vulnerabilities of different target groups to be captured and analysed.
- Supervise and support the setup of systems in SC IT's programmes to manage complex information generated by MEAL activities, such as complaints databases and qualitative outcome monitoring data systems.

Accountability & Participation:

- Ensure that programme staff in SCIT' priority countries fully understands and promotes accountability to beneficiaries, and to children in particular, through training and coaching. Ensure that programme activities are designed to promote feedback and response mechanisms and include systems to effectively manage complaints.
- Support the establishment of accountability systems for staff, partners and beneficiaries in SCIT's priority countries to enhance effective accountability for Save the Children and Partners. Ensure accountability, protection and participation-related indicators and produce relevant reports consolidating data by programme teams.

Representation & Organisational Learning:

- Represent the Organisation in key events and meeting when required
- In collaboration with MEAL colleagues in priority countries, feed in learning, experiences and evidence to relevant global advocacy objectives.

Technical supervision, and capacity building of staff:

- Management of staff and MEAL activities in International Programmes Division
- According to SCIT MEAL strategic commitments: Strengthen and execute a Monitoring and Evaluation system which will drive our quality programming; Develop and execute a Learning System on identified programming strategic priorities; Contribute to leveraging knowledge in SCA on SC IT's high priorities, generating evidence, improving learning and generating innovation (new methodologies, approaches, best practices, tools); Ensure alignment with and use of SCA's Quality Framework
- Work with programme teams in SCIT's priority countries and support development of sector log frames, plans, and monitoring and evaluation frameworks and plans.
- With support from colleagues, support fundraising, including contributing to the regional proposal writing and review of country based proposal to ensure MEAL activities and costs are adequately covered.
- Identify learning and training opportunities for MEAL staff and work as a mentor for less experienced staff



 Conduct training and awareness raising activities for operations and programme technical staff at field and country-office level regarding MEAL priorities and quality standards.

General:

- Ability to work both in a hands on implementation and advisory capacity
- Available to travel frequently
- Experience of contributing to successful funding proposals for donors
- Ability to write clear and effective assessment and project reports with high level of written and spoken English
- The capacity and willingness to be extremely flexible and accommodating in difficult and sometimes insecure working circumstances.
